WILDFLOWER WALK AT MERWIN PRESERVE WITH LOCAL NATIVE PLANT EXPERTS

ParkLand's enjoyed a larger-than-expected gathering and perfect weather conditions for the Wildflower Walk on May 5th of this year. To accommodate all attendees, experts Dr. Joe Armstrong (Emeritus Professor of Botany) and Dr. Roger Anderson (Emeritus Distinguished Professor of Ecology) both led groups across the Merwin Preserve to explore the site and learn about local wildflowers. Janice Turner (an Illinois native plant expert) also helped lead a walk and provided her expertise. About the large turnout, ParkLands Director Jim Franks mentioned "The last time I did a wildflower walk a few years ago, I was the only participant. I had Dr. Dale Birkenholz all to myself. So, having 50 people show up was a great turnout." President Dan Deneen noted that the great turnout was in response to the ParkLands Outreach committee's hard work in the last few years. Walkers were able to see many different native species of flora and learned a bit of biology along the way. Perhaps unsurprisingly, the highlight of the walk was the spring bloom of bluebells. The walk took place at the peak time of year to see these native blossoms in their full glory, which create a stunning sea of blue across the woodland floor.

We are writing to request your help! ParkLands Foundation is pleased to announce that we recently received a **challenge grant for \$21,000** from the Illinois Clean Energy Community Foundation (ICECF) to support ecological restoration and stewardship efforts at one of our nature preserves along the upper **Mackinaw River**: Chinquapin Bluffs Land and Water Reserve in Woodford County.

The ICECF grant will give us \$3 for every \$1 that we raise specifically for this project from the general public for a maximum award of \$21,000 from ICECF. In addition, we can receive \$4,000 once 400 hours of stewardship work by volunteers is reached at the preserve.

In order for ParkLands to achieve these goals, we must raise at least \$7,000 in matching funds dedicated towards our natural habitat restoration efforts at the Chinquapin Bluffs preserve <u>and</u> involve more people from local communities in our stewardship activities at this preserve.

Chinquapin bluffs land and water reserve includes 757 acres located west of Kappa and south of Secor, and is being restored to native prairie and wetlands. We have included a more in depth description of the preserve in the following pages. We will use the funding to maintain wetlands through tree thinning, controlling invasive lespedeza, and conducting prescribed burns on 100 acres of prairie and hill prairie on the preserve.

Please consider giving a donation to the Chinquapin Bluffs Stewardship Fund to help us reach our ICECF challenge grant goals. If you are unable to donate funds to our efforts, please consider volunteering your time to help with our stewardship activities at the Chinquapin Bluffs Preserve. No matter how small or large, your valuable contributions will help us!

Thank you for assisting us in our efforts to increase conservation acreage in the Mackinaw River watershed, protect and improve the ecological health of the river corridor, and provide for passive public nature recreation and education.

Chinquapin Bluffs Land and Water Reserve

The 757.19-acre Chinquapin Bluffs Land and Water Reserve is owned by Parklands Foundation and is adjacent to the Mackinaw River. The preserve is located in Palestine and Kansas Townships in Woodford County, Illinois. William Bateman purchased the land now known as the Chinquapin Bluffs around the time of the Civil War. In 1997 the Nature Conservancy (TNC) purchased the property as part of their focus on reducing flooding and sediment loads on the Mackinaw River. In 2008 the Nature Conservancy transferred title to the ParkLands Foundation due to the great work that ParkLands Foundation was doing in the surrounding Woodford County area. The preserve is now protected in perpetuity with the Illinois Nature Preserves Commission, a division of the IDNR, as a Land and Water Reserve.







With funds raised from individuals and ICECF we plan on removing invasive species from 120 or more acres, thinning woody species at two wetlands, as well as conducting prescribed burns on an additional 100 acres of restored prairie grasses and forbs. We will also be purchasing equipment to assist our new Volunteer Stewards at the site. Work days will be held at the sites throughout the year to recruit more community involvement and outreach with the community. The above listed activities will help the preserve directly, as well as remove the threat of spreading invasive species onto our other savannas, prairies, and other restoration areas down stream of this preserve.
